## COMPLIANCE NOTICE – SECTION 44 WELSH LANGUAGE (WALES) MEASURE 2011

### The British Broadcasting Corporation – Issue Date: 30/09/2016

Section 67 of the Welsh Language (Wales) Measure 2011 provides that the Commissioner is not authorised to require a body to comply with a standard if, and to the extent that, the standard relates to broadcasting. However, broadcasting does not include any activity that is carried out in connection with broadcasting.

As a result of implications under section 67 of the Welsh Language (Wales) Measure, 'Exception for broadcasting', it is considered that the service delivery standards in this compliance notice are relevant to:

- **Audience Services** – which means the provision of customer services by the BBC in response to feedback and queries received on its platforms from its audiences;
- **Corporate Services** – which means the provision of information, publicity and other services to the public as part of BBC Wales' consultation, policy, strategy, HR, property and finance functions that do not directly relate to programmes;
- **TV Licensing** – which means the administration and enforcement of the television licence fee by the BBC and its agents.

**This statement does not apply to standard 53 as the requirement to comply with that standard is already limited to specific circumstances within the applicability of section 67 of the Welsh Language (Wales) Bill 2011.**
